COMMISSION CONSIDERATION:

Mayor Snowden announced the following: "We are now convening a public hearing to discuss the millage rate and budget. We will begin with a discussion of the final millage necessary to fund the final budget for the City of Lake Helen. The proposed final millage rate to be levied is 7.8 mills or \$7.80 per \$1,000 of valuation, which is a 6.78% increase above the rolled-back rate. The rolled-back rate is 7.3046 mills or \$7.30 per \$1,000 of valuation."

Mayor Snowden said: “the City of Lake Helen’s rolled-back rate is 7.3046 mills or \$7.30 per \$1,000 of valuation. The proposed final millage rate to be adopted for fiscal year 2017-2018 is 7.8 mills, or \$7.80 per \$1,000 of valuation, which is a 6.78% increase over the rolled-back rate.”

City Attorney Scott Simpson read the Title of RESOLUTION 2017-15: A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF LAKE HELEN OF VOLUSIA COUNTY, FLORIDA, FOR THE 2017-2018 FISCAL YEAR; ADOPTING THE FINAL LEVYING OF AD VALOREM TAXES AT A MILLAGE RATE OF 7.8 MILLS (WHICH IS HIGHER THAN THE ROLLED-BACK RATE OF 7.3046—AN INCREASE OF 6.78%) AND PROVIDING AN EFFECTIVE DATE.
